- 4. Creating awareness and sensitivity at all levels of social structure to inculcate the consideration for PwD by everyone in all aspects of everyday living by education, example and legal mandate with effective implementation mechanisms.

5. Foster innovation, creativity and entrepreneurship in the youth to develop indigenous designs and solutions appropriate for Indian conditions for providing the accessibility to all types of disabled people of our country.

If we can create a ripple effect of awareness in today's Indian society by meeting the abovementioned goals by 2020, we can be living in a country that can proudly proclaim to be an Inclusive Society like many other Developed and developing countries. ABA's social awareness campaign will yield Social Mindset Change that will be opening up to rapid assimilation of PwD in the mainstream of India from Educational Institutions, Corporate houses, Administrative and Executive offices to the Echelons of political power thus creating an environment of equality, dignity and Independence for all citizens in the true sense.
